

**M&M SERVICES, INC. t/a TOMORROW'S ICE**  
***Waiver of Liability, Release, Assumption of Risk and Indemnity Agreement***

For and in consideration of participant's registration with M&M Services, Inc., (hereinafter M&M) and being allowed to participate in M&M's camps, clinics, events and member team activities, the parent(s) or legal guardian(s) of participant relinquish any and all liability for any cause of action for personal injury, property damage or wrongful death occurring to participant arising out of participation in M&M's camps, clinic, events, member team activities, relative to the sport of ice hockey and/or activities incidental thereto, whenever or however they occur and for such period as said activities may continue, and by this agreement any such claims, rights and causes of action that participant may have are hereby relinquished and the participant (or parent(s)/guardian(s)) does(do) so on behalf of my/our and participant's heir, executors, administrators and assigns.

Participant and/or participant's parent(s)/guardian(s) acknowledge, understand and assume all risks inherent in ice hockey and any member team activities, and understand that said sport and activities involve risk to participant's person, including bodily, partial or total disability, paralysis, and death, and damages which may arise therefrom and that I/we have full knowledge of said risks. These risks and dangers may be caused by the negligence of the participant or the negligence of others, including M&M. It is further acknowledged that there may be risks and dangers not known to us or are not foreseeable at this time.

Participant and or participant's parent(s)/guardian(s) acknowledge, understand and assume the risks, if any, arising from the conditions and use of ice hockey rinks and related premises and acknowledges and understands that included within the scope of this waiver and release is any cause of action, arising from the performance, or failure to perform maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said rinks or negligent supervision or instruction.

Participant or participant's parent(s)/guardian(s) agree if any claim for participant's personal injury or wrongful death is commenced against M&M, he or she shall defend, indemnify and save harmless M&M from any and all claims or causes of action by whomever of wherever made or presented for participant's personal injuries, property damage or wrongful death.

It is the purpose of this Agreement to exempt, waive and relive M&M from any liability for personal injury, property damage, and wrongful death caused by any negligence, including the negligence, if any, of M&M, its member teams, event hosts, other participants, coaches, officials, sponsors, advertisers, owners, and operators of the premises used to conduct any event and each of them, their officers, directors, agents and employees.

Participant and or participant's parent(s)/guardian(s) acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representations of M&M, that they are fully advised of the potential dangers of hockey and understand these waivers and releases are necessary to allow ice hockey to exist in its present form.
